1. A completed ARC Request Form, indicating the color combination that you are considering; **color(s) chosen by the owner MUST be selected from the APPROVED PAINT COLOR SELECTION LIST.**

2. A sample of each color which identifies where each color is to be used (i.e., trim, body, etc.).

3. Approval of the new color scheme by the **ARC IS REQUIRED prior to proceeding.** In approaching your choices, please note that the Association does not allow adjacent homes to use the exact same color combinations.

PLEASE NOTE IF PAINT SAMPLES ARE NOT PROVIDED THE REQUEST CAN BE DENIED/DELAYED.
