Special Projects Committee- Perimeter

On January 10, 2022, Lee County sent a code violation to our Association concerning the condition of the perimeter fence. A copy of the violation is included herein. As everyone is aware, during the removal of exotic plants, Brazilian Pepper trees, our fence was badly damaged and is in need of repairs. At the April board meeting, a new committee was formed, the Special Projects Committee, to deal with this violation and to determine a long range plan for our perimeter.

At the last board meeting, a contract was approved to repair/replace about 2,200 feet of six foot high chain link fence and do other necessary repairs to loose, damaged, falling down, missing hardware and materials. The new Property Manager was extremely helpful in getting the specifications prepared and for inspections by contractors for this work. We are now finalizing the contract with insurance, licenses, etc and obtaining a schedule of work, including the starting date. The contractor, Carter Fence of Naples was chosen from three firms which submitted proposals which including pricing for this important project. It is anticipated that the work will start before the next issue of the Crier when more information, including detailed pricing, is expected to be reported. The fencing portion alone is expected to cost \$42,770. Site preparation, ground conditions, i.e. rock, stumps, etc will be an additional cost. The overall budget for this work is \$70,000.

It was considered very important to get this work started now to meet the non compliance issue and to avoid additional costs in the future due to inflation of the cost materials as well as to deal with supply issues.

A long range plan of this committee is to obtain input from the community, in the form of a membership vote on the following: an eight foot high perimeter precast concrete wall, a higher or stronger fence or other options. It is expected that this membership vote will take place before the end of this year. More details on this will be provided as we move forward. The first priority was to fix the fence as soon as possible.

- 4. <u>Pool</u> Close umbrellas on the pool deck if you use them, as wind will destroy them. Please shower before using the Pool or Spa to rinse off excess tanning lotion or oil. Please report any issues with the pool/spa to the manager.
- 5. **PARKING at the Community Center Lot:** Please keep in mind that anyone parking in the lot for short-term overflow parking will need to notify the office.

Lee County Sheriff's Office Fraud Alert

The Lee County Sheriff's Office Economic Crimes Unit has received calls regarding scammers, once again attempting to obtain personal and financial information from unsuspecting victims.

Be it by email or by text, these criminals are identifying themselves as members of the "Geek Squad," a subsidiary of the "Best Buy" corporation. In reality, they have NO connection to the worldwide consumer electronics corporation.

While the real "Geek Squad" offers computer-related services to consumers, these scammers work diligently to steal personal and financial data.

Please note that these scammers reportedly use a Gmail account for their email messages...as opposed to a "Best Buy" email address.

Reportedly, a number of the email messages received contained noticeable grammatical errors. The messages asked the recipients to phone them to renew their "Geek Squad" subscription. Should you receive these messages, or similar ones, please report them to the Lee County Sheriff's
