Special Meeting

On Wednesday May 5, 2021 there will be a Board Meeting held for the purpose of a discussion with our Attorney to give guidance on questions the Board and Committee Chairs may have. Driving Safety

Drivers in their vehicles are speeding and driving recklessly in our community. Drivers are urged to respect the 19 mph limit. Some drivers have passed those going the speed limit endangering motorists, pedestrians, pets, and bicyclists. This is unacceptable. This is the reason the speed bumps will remain in the community and will be repaired as needed until a better solution can be found. Be aware that speeding over the speed bumps can damage vehicle exhaust systems, steering, shock absorbers and tires. It is highly recommend the speed bumps are gone over slowly. If you see reckless driving that endangers you and/or others you are encouraged to report it. The safety of all of the Westminster residents and visitors is our greatest concern.

Golf Cart Safety

It is against the law for those younger than 14 years of age to operate a golf cart within the community. It is not acceptable even if an adult is in the golf cart. Permitting young children to drive golf cart endangers their and your safety as well as those nearby.
