Feeding Wildlife

Florida law, and WCA governing documents, prohibit the feeding of wildlife, to include ducks, feral cats, alligators, and other animals. A reminder that on street parking is prohibited from midnight to 6AM nightly. Violators are subject to being ticketed and may be fined. Please do not park on the street during these hours.

ARC Approval Needed Before Starting Work

Please remember for any work requiring an ARC approval, the work cannot be started until/unless the application is approved. Owners have been starting projects before ARC approval and doing so may result in a <u>fine</u> to the homeowner. <u>PLEASE DO NOT START YOUR PROJECT WITHOUT ARC</u> APPROVAL.

Compliance - Mailboxes

The Compliance Committee wishes to remind owners mailboxes tend to fade and become dirty over time. Mailboxes should be maintained in an aesthetically pleasing condition. It is suggested you have your house number on the mailbox to assist first responders coming into Westminster.

<u>Compliance – Leashed Dogs</u>

Our Westminster documents require a pet, dog or cat, to be leashed at all times if outdoors. Owners are required to pick-up after their pet. Failure to follow the requirements of this section (5.18) could result in a Violation Notice.

Compliance – Trash and Recycle Containers

Trash and recycle containers are required to be stored in the garage. Containers and vegetation cuttings can be placed curbside on the day of collection or the evening before. Placing containers anywhere other than the garage for storage is a violation of the Governing Documents (5.6).

Lakes and Irrigation

Owners are reminded that the irrigation schedule is set to accommodate lawn and landscape irrigation as well as to maintain the service life of our pumping system. If you are unsure of your irrigation times, the schedule can be found on our website and below. Watering of lawns outside of the set schedule can lead to a Violation Notice.

Irrigation schedule stickers for your controller box are available at the office.

Times for watering are determined by the last number in your address.
