NO TENANT OR LESSEE MAY MOVE INTO OR OCCUPY A UNIT NOR SHALL ANY OWNER PERMIT A TENANT OR LESSEE TO MOVE IN OR COMMENCE OCCUPANCY WITHOUT <u>OBTAINING AN APPROVED APPLICATION</u> FROM THE ASSOCIATION. APPLICANTS ARE SUBJECT TO A \$40 FEE FOR EACH BACKGROUND CHECK FOR PERSONS OVER THE AGE OF 18. \$71 FOR A CANADIAN OR AT COST FOR INTERNATIONAL. SCREENING MAY TAKE LONGER THAN 10 DAYS DEPENDING ON THE NATURE OF SCREENING WHICH MAY REQUIRE ADDITIONAL TIME.

- Rentals are 30 day minimum.
- Limited to single family residency only, no corporate leasing or subleasing outside of a family unit.
- Occupancy is limited to Lessee and immediate family only, additional occupants over 18 are subject to background check.
